| Short Biography of presenter(s) | Senior lecturer: Centre for Medical Ethics & Law, Tygerberg Campus. Anita Kleinsmidt holds BA (UWC), LLB LLM (Wits) and PGDip Applied Ethics (Stell) degrees and is an attorney of the High Court of South Africa. She lectured medical ethics and medical law at the Steve Biko Centre for Bioethics at Wits Medical School until 2007, when she moved to Cape Town and became a legal publisher in Juta's division publishing law texts for attorneys. She is currently employed as a senior lecturer at the Centre for Medical Ethics and Law at the Faculty of Medicine and Health Sciences of Stellenbosch University and in the process of developing an online research ethics course. |
