Short Biography of presenter(s)	<p>Jerall might sometimes introduce himself as a privacy professional and immediately thereafter argue that privacy is not actually a profession. He often gets asked if he is an attorney (he's not). Rather, privacy draws on and co-ordinates a variety of other professions and disciplines. Jerall's career is peppered with IT and audit firm jargon, part-time game design, and board membership of a technology-oriented non-profit.</p> <p>Jerusha is a wearer of many hats. One of them is that she is currently a non-practising attorney. She has a background in general legal practice and in legal and compliance consulting. She enjoys privacy law as an emerging area of law which speaks across all disciplines. She is a fan of good coffee and tasty food.</p>
Blurb (Including Conclusions and Implications for Teaching and Learning at SU)	Privacy is a human right. But, as academics, how do we give effect to that right in the lecture hall? During this session, Jerall and Jerusha will bust several privacy myths. They will also introduce the SU privacy impact methodology—the output of research conducted within the Division for Information Governance—as an enabler, rather than a compliance burden, of innovative teaching practices and technologies.

Opsomming van Uitnodiging	Hiermee nooi SOL u graag na 'n etensuur sessie as deel van die Auxin-projek. Die Auxin-projek se doel is om groeiegeleenthede vir US-dosente te skep.
Titel en Naam van Aanbieder(s)	Jerall Toi, Senior Institusionele Inligtingsbeampte, en Jerusha Naidoo, regskenner in US se afdeling vir Institusionele Inligting.
Kort Biografie van aanbieder(s)	Jerall kan homself soms voorstel as 'n professionele werker in privaatheid, en dan sommer dadelik ook noem dat privaatheid nie regtig 'n profesie is nie.
