### 2. VISION AND MISSION DISCUSSION:

The vision and mission draft has been discussed and will be edited and approved within a week so that it can be put on the website as soon as possible.

# 3. STUDENT PARLIAMENT CODE OF CONDUCT

The code of conduct will remain as is to maintain a level of consistency within the structure.

### 4. LIST OF PRIORITIES FOR THE SRC

A task team will be created to compile the list that allows for input from the student body and takes cognisance of issues reported on by campus news agencies and past SP issues

Thamera and Lukhanyo (accountability vice chair and speaker) will serve on this task team and will decide what its composition will look like.

### 5. FIRST SITTING

Proposed date/timeframe is the week of the 5-9th (possibly specifically the 8th). Either a small session will be held with a high quality screen that will be broadcasted to the public or the reading of commitments will be prerecorded. Whether or not this will be in person will be determined by approval by the university and costs.

### 6. CONSTITUTIONAL REVIEW PROCESS

Another consultation session was held with SRC on the proposed amendments to the Student Constitution that affect Student Parliament.

It looks likely that the changes to the constitution will be so drastic that we need to put our constitutional review process on hold until the Student Constitution is finalised. However SP is also unwilling to not work on our outdated constitution at all until then due to how dysfunctional it is.

No decision can be made on the process until a firm commitment has been received from the SRC that they intend to pass the constitution at the end of the first semester.

## 7. BUDGET DISCUSSION PRESENTED BY THE TREASURER

The registration of vendors and reclamation of funds when members incur expenses on behalf of the committee was explained by Maks as was relayed to him during his financial literacy session with Mr Fritz.

The preliminary budget framework was discussed and shown to the committee.
