<a href="#">Unit for Religion and Development Research</a>	The Unit for Religion and Development Research (URDR) is an interdisciplinary research unit based at Stellenbosch University, South Africa. It empowers communities, organisations and governments for development through evidence-based research, theory building from below and capacity building through education and training. The URDR offers a unique research space, positioned within multiple worlds, with a focus on social transformation and sustainable development. This enables it to sensitively navigate the faith and secular divides still prevalent in development work today; to nurture cooperation between the worlds of theory and practice, academics and faith institutions, and government and civil society; and to offer multi-sectoral, interdisciplinary approaches to the complex issues surrounding key sustainable development goals. <a href="#">Ending Child Violence, Nurturing Child-Friendly Churches: A pilot action research collaboration (Between a community organisation, an academic research unit and a local church)</a>	The aim of the project is to investigate how local churches can be better equipped to play a constructive role in ending child violence and nurturing children within its own spaces and programs. It pilots a collaboration between a community project, a local church and an academic researcher to formulate a hybrid model of intervention, reflection and participatory evaluation within one church. Its unique contribution to the topic of ending child violence and nurturing child friendly churches is that it brings together selected local collaborating partners around a child rights legal framework that takes the theological underpinnings of a church setting seriously with tailored engagement within this space that can directly engage with underpinning child theologies in a local church. <p><a href="#">Protection of stateless persons, prevention of statelessness and the role of Faith Based Organisations in the Southern African Region.</a></p>	<p>From 29-30 August 2018 we plan a colloquium for about 40 academic theologians and law experts, doctoral students and church and community leaders. The colloquium will be held at the Faculty of Theology. The colloquium would be a collaboration between the Faculty of Theology and the Faculty of Law at Stellenbosch University (of the Unit of Law and Religion of the BNS), and the United Nations High Commissioner for Refugees (UNHCR) and Lawyers for Human Rights (LHR). The theme of the Colloquium is Protection of stateless persons, prevention of statelessness and the role of Faith Based Organisations in the Southern African Region. Today, 10 million people throughout the world are affected by statelessness. Estimates indicate that hundreds of thousands of individuals in the Southern African region are among those that no state "considers as a national under the operation of its law". <p><a href="#">The MTh Practical Theology (Ministry Practice) 50784:889</a></p>	<p>The Faculty of Theology offers a two year structured MTh in Practical Theology (Ministry Practice). The programme aims to build missional leadership capacity through reading, vigorous theological dialogue, participation in spiritual disciplines, experimentation with missional leadership challenges and personal reflection (journaling) and direction. The focus and content of the different modules are based on research done in congregations of the Partnership for Missional Churches in Southern Africa (SAPMC). Topics addressed in the MTh Programme: Congregational ministry and spiritual formation; Rethinking our faith: The Gospel, Missio Dei and the Triune God; Pastoral care, spirituality and discipleship; Leading God's people (in partnership with the University of Stellenbosch Business School); Historical and contemporary practices in spiritual direction and community formation; Missiology and missional spirituality for the building of Kingdom communities; Unique Learning Experience. The programme offers students a unique learning experience. It focuses on developing students' skills as missional leaders by reading academic books and articles, reflecting in a learning community, exercising in practice, and articulating and integrating theory through assignments and a research assignment. The point of departure of the learning experience is based on the ecumenical community formed by the students, which is why attendance of modules is compulsory. <a href="#">Winter School</a>	The annual Winter School presented by the Faculty of Theology, Stellenbosch University, is a three day conference for pastors and laity on theological, public and congregational issues. In 2017 the conference took place from Tuesday 13 June to Thursday 15 June 2017 and focussed on the theme Reforming the Church, Society and Ourselves. In the light of the 500 -year celebration of the Reformation the Winter School of 2017 engaged with the need for an ongoing reformation of the church, society, and people. The focus was on what we can learn from the Reformation, but also on discussing ways in which we need to go further and seek new modes of being church in a rapidly changing society. The keynote speakers were Dr Ishmael Noko, President of the Inter-faith Action for Peace in Africa, Judge Steven Majiedt, judge of the Supreme Court of Appeal, and Dr Margaret Blackie, lecturer at the Department of Chemistry and Polymer Science, Stellenbosch University. We want to reach our vision and goals through the use of various methodologies to generate the best results for a given context. <a href="#">Revised Common Lectionary (RCL) South Africa</a>	Word and Worship is an ecumenical resource for worship. Word and Worship is based on the texts of the Revised Common Lectionary. It contains both liturgical and preaching resources. Now in its 7th edition, it has come about due to a collaborative venture between clergy from a number of denominations. It is published annual under the auspices of Ekklesia. There are sermon outlines for each Sunday. A brief hermeneutical exposition is provided with sermon suggestions. These outlines can be adapted to various traditions and contexts. Not every minister may have access to a theological library and these outlines are very user friendly. The BNC was a co-host of this initiative with STIAS and Prof Gobodo Madikizela and Queens University. This is an ongoing collaborative research initiative which is also linked to our Reconciliation Project under the leadership of Prof Christo Thesnaar. <a href="#">Child killings in the Western Cape</a>	Dr Chris Jones, the Beyers Naude Centre's Moral Leadership project leader, is part of a task team doing research on child killings in the Western Cape. 66 children have been killed since the beginning of 2017 in the Western Cape. The Premier has asked that all existing research first be analysed to determine whether this can in itself provide the necessary answers to why the number of murders continues to increase, and what possible interventions may be able to assist in reversing this trend. Such an analysis should also be able to ascertain whether there are any unanswered questions left by the existing available information that may only be able to be addressed by a commission of enquiry, or through another appropriate process or mechanism.
